Uittreksel uit Staatskoerant 46741 gedateer 18 Augustus 2022 is as volg :-

Prohibition on the movement of live cattle

3.
 - (1) Any activities where live cattle are physically moved from one property to another property are prohibited in the whole country;
 - (2) Any person who suspects or become aware of movements of live cattle, except for movements allowed in terms of point 4 hereunder, must report this to their local Stock Theft Units of the South African Police Service and state veterinary authority immediately.

Die Staatskoerant is baie duidelik oor die beheermaatreëls en waar jy dit rapporteer. Om dit nie te rapporteer nie of buite die bepalings op te tree, is 'n oortreding ingevolge artikel 32 van die Wet op Diergesondheid, Wet 35 van 1984 :-

Misdrywe en strawwe

(1) Iemand wat

(p) 'n bepaling van 'n beheermaatreël oortree, of versuim om daaraan te voldoen; is aan 'n misdryf skuldig, en

(bb) by 'n eerste skuldigbevinding aan 'n misdryf bedoel in enige ander paragraaf van hierdie subartikel as 'n paragraaf in item (aa) genoem, strafbaar met 'n boete van hoogstens R8 000 of met gevangenisstraf vir 'n tydperk van hoogstens twee jaar, of met daardie boete sowel as daardie gevangenisstraf;

WHERE AND HOW DO I REPORT THE ILLEGAL TRANSPORTATION OF CATTLE UNDER THE CURRENT FOOT AND MOUTH CONTROL MEASURES

Extract from Government Gazette 46741 dated 18 August 2022 is as follows :-

Prohibition on the movement of live cattle

3.
 - (1) Any activities where live cattle are physically moved from one property to another property are prohibited in the whole country;
 - (2) Any person who suspects or become aware of movements of live cattle, except for movements allowed in terms of point 4 hereunder, must report this to their local Stock Theft Units of the South African Police Service and state veterinary authority immediately.

The Government Gazette is very clear about the control measures and where you report them. Not reporting it or acting outside the provisions, is an offense in terms of Section 32 of the Animal Diseases Act, Act 35 of 1984 :-

Offences and penalties

(1) Any person who

(p) contravenes any provision of a control measure, or fails to comply therewith; shall be guilty of an offence, and

(bb) on a first conviction of an offence referred to in any paragraph of this subsection other than a paragraph mentioned in item (aa), be liable to a fine not exceeding R8 000 or to imprisonment for a period not exceeding two years, or to both such fine and such imprisonment;
